2. Provide proof of insurance on assigned vehicle.
3. General Rules of Use:
  - ✓ No more than two persons and two golf bags should be on the cart at any time.
  - ✓ No one may sit on the back of the cart or stand on the bumper while the cart is in use.
  - ✓ Only members and guests that have a valid driver's license may operate a cart.
  - ✓ Carts should be driven safely and prudently as weather and course conditions allow.
  - ✓ The parking brake should be set whenever leaving cart.
  - ✓ No one should operate a cart if intoxicated.
4. Indemnity and Hold Harmless: I agree to pay for any damages that are sustained to the golf cart or other property that is caused by my use of the cart. I have read and understand the General Rules of Use and I assume the risk of operating the cart in accordance with these Rules. I promise and agree to indemnify, defend and hold harmless the Club, Owners, CourseCo Management Company and their employees, owners, representatives, officers, shareholders and directors from and against any damage, losses, or claims of any nature that may arise from and to the extent are caused by my negligent use of the cart or by my failure to comply with the General Rules of Use described above.
